

2025–2026 Verification Worksheet

Your 2025–2026 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you, and your parents, if a dependent student, reported on your FAFSA. To verify that you provided correct information the financial aid administrator will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You, and at least one parent if you are a dependent student, must complete and sign this worksheet, attach any required documents, and submit the form and required documents to the Office of Financial Aid. We may ask for additional information. If you have questions about verification, contact the Office of Financial Aid as soon as possible so that your financial aid will not be delayed.

INDIVIDUALS WHO FILED A 2023 AMENDED IRS INCOME TAX RETURN

An individual who filed an amended IRS income tax return for tax year 2023 must provide:

- ☐ A **signed** copy of the **2023 IRS Form 1040X, "Amended U.S. Individual Income Tax Return,"** that was filed with the IRS or documentation from the IRS that include the changes made by the IRS; **AND**
- ☐ A **2023 IRS Tax Return Transcript** (that will only include information from the original tax return and does not have to be signed)

OR

- ☐ A **2023 Record of Account Transcript**

OR

- ☐ A **signed** copy of the **2023 IRS Form 1040 and all applicable schedules** that were filed with the IRS.

INDIVIDUALS WHO WERE VICTIMS OF IRS TAX-RELATED IDENTITY THEFT

An individual who was the victim of IRS tax-related identity theft must provide:

- ☐ A **signed** copy of the **2023 income tax return with all applicable schedules** that were filed with the IRS, or an equivalent document provided by the IRS;
AND
- ☐ An IRS 4674C letter (a letter from the IRS acknowledging the identity theft) **or** a statement signed and dated by the tax filer indicating that they were a victim of IRS tax-related identity theft, and that the IRS is aware of it.

IDENTITY & STATEMENT OF EDUCATIONAL PURPOSE *(To Be Signed at the Institution)*

1. The student **must appear in person** at Western New England University to verify their identity by presenting an **unexpired** valid government-issued photo identification (ID), such as, but not limited to:
 - driver's license
 - other state-issued ID
 - passport
2. In addition, the student must sign, **in the presence of the institutional official**, the Statement of Educational Purpose below.

The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.
