Dear first year students,

The Law School Registrar welcomes you to Western New England University School of Law. This letter contains information about registration for courses in the fall 2025 semester.

Your schedule is determined by the division in which you have been admitted whether full-time, part-time day, or part-time evening.

Full-time students and part-time day students will be registered for the following courses and schedule:

- LAW 500-01, Introduction to the Law: This course will meet from August 18 to 21. Your schedule for orientation will provide class session times along with the schedule for other required orientation sessions.
- LAW 695-1A or -1B, Academic Success: Students will be assigned to one of two sections. Starting August 25, this course will meet on Tuesdays (section -1A) and Thursdays (section -1B) from 10:00-10:55 in Room A.
- LAW 513-01, Torts: Starting August 25, this course will meet in person on Mondays and Wednesdays from 10:35 to 11:50 in Room A. It will also have asynchronous online content that is the time- and preparation- equivalent of one class session each week.
- LAW 509-01, Civil Procedure: Starting August 25, this course will meet on Tuesdays and Thursdays from 11:15 to 12:30, as well as Wednesdays from 1:00-2:15, in Room A.
- LAW 505-01, Criminal Law: Only full-time students will be registered for Criminal Law. Starting August 25, this course will meet on Tuesdays and Thursdays from 2:00 to 3:15, as well as Mondays from 1:00 to 2:15, in Room A.
- LAW 507, Lawyering Skills I: Students will be assigned to one of five sections. Starting August 25, this course will meet on Monday and Wednesdays from 9:30 to 10:25 (sections -01 and -03) and Mondays and Wednesdays from 2:30-3:25 (sections -05, -09, and -11).

Part-time evening students will be registered for the following courses and schedule:

- LAW 500-41 Introduction to the Law: This course will meet in person from August 18 to 21. Your schedule for orientation will provide class session times along with the schedule for other required orientation sessions.

- LAW 695-41, Academic Success: Starting August 25, this course will meet in person on Wednesdays from 7:35 to 8:25 in Room A.
- LAW 513-41, Torts: Starting August 25, this course will meet on Mondays and Wednesdays in person on Wednesdays from 6:00 to 7:15 in Room 3, and online on Thursdays from 7:30 to 9:15.
- LAW 509-51, Civil Procedure: Starting August 25, this course will meet online on Tuesdays and Thursdays from 7:00 to 8:15. It will also have asynchronous online content that is the time- and preparation- equivalent of one class session each week.
- LAW 507-41, Lawyering Skills I: Starting August 25, this course will meet on Mondays from 7:30 to 8:55 in Room 3. It will also have asynchronous online content that is the time- and preparation- equivalent of half of one class session each week.
