- On Thursday September 27th Western New England University College of Pharmacy and Health Sciences (WNE COPHS) hosted an interprofessional group of 170 local healthcare students including Physician Assistant learners from Springfield College and Bay Path University as well as Occupational Therapy and Pharmacy learners from Western New England University for a screening of the Patient Safety Documentary “To Err is Human”. The film addresses harm from medical errors and highlights the case of the Sheridan family who suffered 2 medical errors, one resulting in a child with a significant disability and the other likely resulting in the premature death of the father. The latest estimates suggest that as many as 220,000-440,000 Americans die prematurely every year due to errors in their care. The purpose of this documentary was to raise awareness of this silent epidemic and to offer suggestions from Patient Safety experts on a potential path forward. The documentary was followed by a panel discussion featuring local patient safety advocates and facilitated by Mark Klee, Pharm.D. Clinical Assistant Professor at WNE COPHS. The panel included Suzanne Nevins, A Neonatal Nurse from Northshore Medical Center who also suffered an unexpected outcome after surgery, Charles Milch who is a practicing clinician and the Chair of the PA program at Springfield College, Elizabeth Isaac who is the Medication Safety Pharmacist at UMASS Memorial in Worcester, MA and Karen Johnson who is the Sr. Director of Patient Safety for Baystate Health. This was only the third viewing of the documentary in Massachusetts, with the other two being at the Harvard School of Public health and Children’s Hospital in Boston. Proceeds from concession sales from this event were donated to the Massachusetts Coalition for the Prevention of Medical Errors.

Of the 46 students who began pre-pharmacy in the fall of 2017, 21 students (45.7%) qualified for the early decision cohort admissions interview [based upon pre-pharmacy GPA and course grades following year one]. Of these 21 students, 14 met the application requirements for the early decision cohort to receive his/her guaranteed interview. All of these students were accepted to the Pharm.D. program, and all accepted the offer of admission.

Among the 32 students in the pre-pharmacy cohort that started fall 2017 who did not apply early decision:

- 7 were eligible to apply early decision and elected to apply regular decision; all were accepted to the Pharm.D. program, and 6 (85.7%) accepted the offer of admission; the one student who declined admission is enrolling at St. John's University Pharm.D. program for fall 2019
- 11 were ineligible to apply early decision and applied regular decision; 7 were admitted, 1 was denied, and 2 applied but are presently ineligible for admission due to pre-requisite coursework or pre-requisite grades. One individual is awaiting an admissions decision.
- 2 remained in the pre-pharmacy program but did not apply to the Pharm.D. program
- 12 changed majors or withdrew from the University

The Doctor of Pharmacy program received 7 applications from WNE students who were never enrolled in the pre-pharmacy program. Of these 7 students, all were interviewed; 6 (85.7%) were admitted to the program, and all accepted the offer of admission. The remaining individual remains on the waitlist.

The Doctor of Occupational Therapy program received 113 applications for admission for the incoming Class of 2022. The current status of these applicants is presented below (as of July 10, 2019):

### Occupational Therapy

#### Goal #1:

Develop and implement an innovative, entry-level Doctor of Occupational Therapy (OTD) Program that prepares entry-level graduates for leadership roles in a global healthcare marketplace, by educating responsive, culturally sensitive, evidence-based, interprofessional healthcare practitioners.

- A. Design and implement the courses in the second year of the curriculum.
- B. Continue the process of curriculum mapping to ensure that the curriculum design themes and threads are being integrated within and across courses and course sequences.
- C. Review development/implementation of process for securing Level I Fieldwork sites that include both transformative (emerging practice areas) and traditional settings.
- D. Further conceptualization of the Doctoral Experiential courses in the second and third years of the curriculum, and implementation of the second year courses.
  1. Initial development of new brochure that targets external partners for collaborative relationships in the formation of Doctoral Experiential Residency Project sites.
  2. Further development/implementation of the process and procedures for the Doctoral Experiential Residency to include a marketing tool that will serve as a “playbook” for an introduction to the residency concept and the basis for operationalizing the site-based project that includes contracting, supervision, site logistics, student/supervisor responsibilities, etc.

#### Goal #2:

Ensure that a critical outcome of the OTD program is that graduates are provided with a conceptual framework and applied strategies to excel at client-centered, evidence-based, collaborative interprofessional practice, as a means to innovatively transform the way that patients/clients receive care in current medical and emerging health care and community based settings.

- A. Continue to include interprofessional education/practice (IPE/IPP) as a core curriculum design perspective for purposes of course development, fieldwork implementation, faculty research and student scholarship.
  1. Further develop/implement classroom and/or experiential interprofessional opportunities for OT students to learn with and through other students in health and related professions (e.g. pharmacy, nursing, bio-medical engineering).
- B. Continue to provide membership in the PV- IPEC organization (Program Director) and engage faculty (clinical) to be involved in the planning and implementation of faculty and students in IPP simulation activities with other healthcare professionals.

#### Goal #3:

Academically develop and support a high quality graduate occupational therapy faculty membership who will excel in professional teaching, learner mentorship, and scholarly roles in ways that will enhance the reputation of the Division, the COPHS and Western New England University.

- A. Establish faculty resources at an appropriate level to meet the mission, philosophy, and vision of the OTD program.
  - 1. Continued search for FTE faculty positions to permit the Division to be at full faculty resources to ensure that program and student learning outcomes are met.
  - 2. Continued implementation of a faculty professional development process that supports early career faculty in the areas of teaching, scholarship, clinical excellence, and service.
- B. Support the participation of OT faculty members on University Committees, as well as College of Pharmacy and Health Sciences, and Division of Occupational Therapy faculty committees.

Goal #4:

Enhance the image and visibility of the academic Division of Occupational Therapy within the College of Pharmacy and Health Sciences and the larger WNE community.

- A. Support the leadership of the Division to advance leadership and management skills necessary for a developing doctoral program.
  - 1. Maintenance of a budgeting process utilizing a single-year budget structure that supports continued program development and affords a long-term vision for program sustainability.
- B. Contribute to the revision of the College of Pharmacy and Health Sciences Faculty Handbook by reviewing content and policies to insure a seamless integration of occupational therapy into the college structure, e.g. definition/responsibilities associated with faculty rank, development, workload, scholarship and research requirements.
- C. Continue to operationalize the admissions process under the auspices of the COPHS Student Affairs Committee including application management, the admissions review process, and the procedures for decision-making and providing offers of admission.
  - 1. Introduced interviewing into the admissions process.
  - 2. Revised the admissions deposit process to reduce the loss of deposited students (increased the deposit amount).
  - 3. Analysis of the data from the first three cohorts to be used in identifying a WNE-OTD student profile (e.g. demographics, undergraduate degree, ethnicity, gender, etc.).
  - 4. Submitted a proposal for an addendum to the COPHS By-Laws adding the Division of Occupational Therapy Admissions Committee is in the planning stage. The proposal will be presented to the Faculty Affairs Committee and the COPHS in AY2019-2020
- D. Implement the OTD program's program evaluation plan.
  - 1. Continue to work with the Assistant Dean for Assessment and Accreditation to utilize the COPHS procedures for collecting data on the following assessment measures: course evaluations; instructor evaluations; learner satisfaction surveys; and advisor satisfaction surveys.
  - 2. Continue to collect/analyze data on additional Division metrics: (e.g. faculty hiring/retention; faculty development/scholarship; faculty standing in the COPHS; budgetary support, etc.) and program metrics (e.g. student retention, fieldwork placements, analysis of grades, fieldwork performance, etc.)
  - 3. Organize and submit data to complete an annual ACOTE report and COPHS report that documents the evidence used to assess the extent to which the program's long term goals are being met, action steps are being accomplished and planning is being updated as

circumstances change.

4. Submission of a proposal for an addendum to the COPHS ByLaws adding the Division of Occupational Therapy Assessment Committee is in the planning stage. The proposal will be presented to the Faculty Affairs Committee and the COPHS in AY2019-2020.
5. Review/Revise marketing/student recruitment plan to leverage market potential.
  - a. Review/revision to existing marketing materials for inclusion in the COPHS brand.
6. Completed planning for the formation of a Professional Advisory Board to provide the developing OTD program with guidance regarding current and future clinical practice, and to serve as resources for developing fieldwork and doctoral experiential residency partnerships in the community. First PAB event to take place in AY2019-2020.
